



# AGREEMENT ON THE GOVERNANCE OF SDMX ARTEFACTS FOR

## INTERNATIONAL MERCHANDISE TRADE STATISTICS (IMTS)

21 APRIL 2016

## **Maintenance Agreements**

This agreement follows the principles stated in the guidelines of the Governance of Commonly Used SDMX Metadata Artefacts<sup>1</sup>.

#### In addition:

The SDMX Sponsor committee agrees that a single ownership group (OG) comprising of Eurostat, International
Monetary Fund (IMF), International Trade Centre (ITC), Organization for Economic Cooperation and
Development (OECD), United Nations Statistics Division (UNSD), and United Nations Conference on Trade and
Development (UNCTAD) should be responsible for maintaining IMTS DSDs. The OG will consult other major
stakeholders as appropriate. For SDMX-IMTS, the ownership group and the technical group are synonymous as
the same organizations worked on governance and technical aspects

- 2. Change requests: SDMX Sponsor committee recognises that the respective MA will only apply changes which are agreed upon by the OG. Agreements are to be based on consensus. Three types of changes are foreseen: structural changes, annual maintenance changes and fast-track maintenance changes:
  - a. Structural changes would be triggered by changes in methodological guidelines or from a comprehensive review of the content of official data flows. This would involve a full review of the entire set of DSDs, including possible restructuring or replacing of concepts and code lists and will only be done through extensive consultations.
  - b. Annual maintenance changes could be proposed by anybody, and would serve the purpose of allowing for new data exchange needs by any party. All such change requests will be analysed and assessed with due care. In particular, the OG will ensure consultation among all its members and major stakeholders.
  - c. Fast-track maintenance changes can be proposed by any of the organisations represented in the OG. Only changes not breaking backwards compatibility can be issued as fast-track. Fast-track changes follow the same change management process as normal changes but are applied with immediate effect if approved and do not need to wait until the next annual maintenance cycle. Fast-track change requests are subject to review in the following annual maintenance cycle.
- 3. Versioning follows the SDMX versioning guidelines<sup>2</sup>.
- 4. If change requests to cross-domain artefacts are filed to one of the MAs, all other MAs will be informed, and the request will be forwarded to the SDMX SWG as a general change request. In the case that the change is approved by the OG but rejected by the SDMX SWG for general use, the artefact might be moved from "cross-domain" to "cross-domain based, shared" in order to accommodate changes which are of interest to IMTS but not for general use. The same principle will apply to artefacts shared with other domains (see code lists types below).
- 5. The OG will apply the same governance for changes to this document as for the technical artefacts.

#### **Code List types**

**SDMX Cross-Domain Code Lists (CDCLs)** 

SDMX cross-domain code lists are those that have been officially adopted so far by the SDMX Secretariat based on proposals from the Statistical Working Group (SWG).

Code lists based on SDMX Cross-Domain Code Lists or National Accounts (NA), Balance of Payments (BOP) and Foreign Direct Investment (FDI) SDMX (MES-E)

Some code lists were based on SDMX Cross-Domain Code Lists or SDMX for Macro-Economics Statistics (SDMX-MES) but extended and/or modified to meet IMTS statistics needs.

A change request for the common/shared parts of these code lists will be forwarded to the respective OG. Decisions regarding changes to the IMTS specific parts will be undertaken by the IMTS OG.
